5. Sealed Bids in plain envelopes marked “**Supply and Erection of Clear View Fencing at Friebel Estate**” and addressed to the above address must be hand- delivered to the above office on or before **14th March, 2023 at 12:00hrs** and must be accompanied by a bid security of: **M10,000.00**

Evidence of tender fee payment and bid security must accompany the tender submission. Failure to produce the proof of tender purchase and requisite bid security shall lead to disqualification to participate in the tender.

The tenderers shall on collection of the tender documents, give the office address at which notices may be validly served upon, together with names of the principals to whom the notices shall be addressed and the official telephone, fax number and Email address.

6. Mandatory Site inspection will be held on the **17th February 2023** and will start at **10.00hrs** at the LHLDC Head office situated at 81 Constitution road Maseru. Tenderers must provide own transport to and from the site and a question-and-answer session will be held immediately after the inspections. Attendance at the site inspection is a condition of tender and as such failure to proof attendance will disqualify bids.
